Mr. Faruque Hossain is the Secretary (PRL), Govt. of Bangladesh and Former Executive Chairman of the National Skills Development Authority, under Prime Minister's Office of the Government of Bangladesh. He served as the Director General (Additional Secretary of the Government) of the Central Procurement Technical Unit (CPTU), Implementation Monitoring and Evaluation Division of

Ministry of Planning, Government of Bangladesh.

Mr. Hossain is engaged in public procurement trainer since the reform in public procurement is initiated in Bangladesh.
