Dr. Md. Humayun Kabir
Former Secretary, Govt. of Bangladesh

Dr. Md. Humayun Kabir is the Former Secretary at the Ministry of Railways (MoR), Government of Bangladesh. He joined in the Bangladesh Civil Service in the year 1993. Dr. Humayun received his PhD in Public Private Partnership (PPP) from Monash University, Melbourne, Australia. He completed his Master Degree in Public Policy and Management from Monash University as well. He also did his Master and Bachelor with honors degree in Public Administration from the Department of Public Administration, University of Dhaka. His area of research interests is: Public Private Partnership, Public Policy & Policy Analysis, Strategic Management, Human Resource Management, International Business etc.

Dr. Humayun has extensive teaching experiences in overseas. He was a part-time lecturer at Monash College, Monash University and RMIT University in Melbourne, Australia and Hong Kong Campus. He was also a sessional teacher at Swinburne University Melbourne. Dr. Humayun was a part-time lecturer at BRAC University as well. He conducted lectures on PPP at different training institutes like BPATC, BCS (Admin) Academy, Bangladesh Institute of Management (BIM), Bangladesh Institute of Governance & Management (BIGM) etc.

Dr. Humayun worked as Assistant Commissioner & Magistrate, in Barguna, Jhenaidah, Satkhira and Kushtia districts. He was also UNO at different Upazilas. He performed his duties as Senior Assistant Secretary and Deputy Sectary in different Ministries as well. He also worked at the PPP office under Prime Minister Office.

Dr. Humayun attended many International Conferences/Seminars and presented papers on different Management topics. He also published several articles on PPPs in the International Journals. Dr. Humayun was awarded as the best DC in Khulna Division in the year 2015 & 2016 respectively for his remarkable contribution in Innovation and Digitalization for service delivery. During his tenure as Deputy Commissioner, Jashore was awarded as the best Digital District by the Honorable Prime Minister. Dr. Humayun Kabir also awarded by the Honorable Prime Minister as the best DC for his outstanding contribution for the development of Primary Education in 2016. Technical Unit (CPTU), Implementation Monitoring and Evaluation Division of Ministry of Planning, Government of Bangladesh.

Mr. Hossain is engaged in public procurement trainer since the reform in public procurement is initiated in Bangladesh. He is certified National Trainer of public procurement, and a qualified resources person of Chartered Institute of Purchasing and Supply (CIPS), UK, and a trainer of Public Private Partnership. He worked closely in developing the public private partnership legal, institutional and financing framework in Bangladesh. He also served as Head of PPP Unit in Finance Division, Ministry of Finance. As a member of the Bangladesh Civil Service Administration, he worked in different Ministries as well as in the field level, with experience in project facilitation, preparation, negotiation, implementation and monitoring with active role in procurement management.

After his MSC in soil science from Dhaka University, Mr. Hossain completed MBA in 2005 and Masters in Public Procurement Management for Sustainable Development from Turin School of Business, Turin University in 2014. He obtained certification on Public Private Partnership (PPP) from IP3 @ Washington, USA, and PAI, London, UK. He also has achieved Diploma in Developing Economics from IDE advanced school, Japan.

Before joining IIFC, he was the Executive Director of Ashrafee Group of Companies. He brings over 23 years of experience in Corporate Affairs, Legal and Compliance, Assurance and Taxation, Cost Audit, Finance and Accounting, Human Resource Management (HRM), Performance Management Systems (PMS), Organizational Reform, Capacity Building, and Project Management. He received the HR

Excellence Award from the Indian Society for Training and Development (ISTD) in 2023 in India and is a certified Emotional Intelligence graduate.

Currently, he is working on several assignments. He is serving as the Financial and Economic Analyst for the construction of the Trishal 132/33kV Grid substation under BREB. Furthermore, he is involved as the Team Leader in the Consultancy Services for the Feasibility Study on Establishment of National Academy for Primary Education (NAPE) Capacity Development Project, Preparation of DPP and Master Plan for (a) Infrastructure Development of NAPE, (b) Capacity Development of NAPE Personnel & Stakeholders, and (c) Building a Modern NAPE.

He has successfully carried out numerous projects at IIFC.
